Steve Clews – all things railways and canals

Trustee of Shropshire Union Canal Society, working on restoration of Montgomery Canal at Crickheath. Latest project has taken 7 years and cost £1million, mostly in grants, all run by volunteers and has won civil engineering project award. Next project is in planning for the next 600m south of Crickheath for a similar cost

Chair of WLLR for 8 years and director of Heritage Railways Association. 3 difficult years for heritage railways, covid, cost of coal rising and lack of availability, challenge of finding coal alternative and rising energy costs. Problem with dry summer, sparks causing line side fires. Volunteers not returning after covid.

WLLR will have a reduced timetable in 2023 but will concentrate on events and higher end products which generate more money.

Chris Toller– putting Henstone Distillery and Oswestry on the English whisky map, see attached presentation.

Started business in 2015. Still installed 2017, a 1000 litre pot/column hybrid called Hilda. Whisky launched in January 2021 with launch events held via zoom.

Chris now a director and board member of the English Whisky Guild, which is the Scottish Whisky Association equivalent.

New versions of whisky being launched soon to coincide with the first English Whisky Festival.

Increase in number of tours next year to 2 a month, encourages people to stay in the area.

Possible tasting with a train ride, WLLR.

Increase in online sales and exported to Switzerland, Hong Kong and Belgium.
